BOARD OF COUNTY COMMISSIONERS

SEPTEMBER 7, 2023

A Public Hearing on Proposed County Budget Fiscal Year 2023/2024 was held at the Charlotte Harbor Event and Conference Center, 75 Taylor Street, Punta Gorda, Florida.
