Gordon Burger, Budget and Administrative Services Director gave a brief overview of Agenda, Fire/EMS Funding, County Comparison: Methodology, Methodology - Fire Rescue, Fire Rescue, Equivalent Millage: Fire, Fund Balance vs Fire Rates, Fires Assessment Rates, Fire Assessment: Equivalent Residential Units (ERUs), Assumptions - Presented 3/21/2023: Fiscal Year 2024 and 2025, Fiscal Year 2026 – Fiscal Year 2031, Rate Scenarios - Presented 3/21/2023, Rate Scenario - Presented 7/17/2023, Charlotte County - Fire: 25% in 2024, then 6% annually - Presented 7/17/2023, Revised Assumptions, Revised Recommended Rate Scenario, Charlotte County - Fire: 15% in 2024, then 6% annually, responded to agricultural exemptions, property classifications, conservation easements, revenue, Non-Ad Valorem tax type, and Municipal Service Taxing Units (MSTUs).

Chief Jason Fair, Public Safety Director gave a brief overview of Charlotte County Fire/EMS, Service Demand, Peak Call Responses, Temporal Distribution, Unit Hour Utilization, Response, Geographical Drive Time Analysis - 6 Minute, 2022 Call Volume (37,868), Station 17 - South County 2025, Station 18 - Edgewater 2026, Station 19 - Gasparilla Rd. 2027, Babcock Stations - East County, Day Time Units, Additional Personnel, replied to challenges, public safety, hiring and onboarding process, salaries, equipment, and inflation.

John Elias, Public Works Director gave a brief overview of West Charlotte Stormwater MSBU: Where Does Your MSBU Dollar Go, and remarked on Street and Drainage Unit methodology.

Chair Truex spoke to West Charlotte Stormwater MSBU: Where Does Your MSBU Dollar Go, West Charlotte Stormwater MSBU Advisory Board, and Animal Welfare League. Commissioner Constance mentioned Fire Assessment: Equivalent Residential Units (ERUs), vacant and occupied lots, scrub jay habitats, Habitat Conservation Plan (HCP), tax rolls, Assumptions – Presented 3/21/2023: Fiscal Year 2024 and 2025, growth, impact fees, funding, standards, challenges, Condition Red, vacancies, property location, frontage, and methodology. Commissioner Deutsch discussed staffing challenges, first responders, salaries, mandatory overtime, inflation, property taxes, and responsibility. Commissioner Doherty commented on Revised Recommended Rate Scenario, concepts, Reserves, Suncoast Waterway MSBU Advisory Board, September 17, 2023 MSBU Public Hearing, public comments, and member applications. Commissioner Tiseo noted public comments and safety, professionalism, community outreach, funding, Assumptions – Presented 3/21/2023: Fiscal Year 2024 and 2025, impact fees,

payroll, overtime, staffing challenges, standards, methodology, growth, homestead exemptions, tax bills, rate structure, economy, impacts, Sunseeker, Charlotte Harbor Community Redevelopment Agency (CRA), property rights and acquisitions, new development, Methodology – Fire Rescue, homesteaded properties, Save Our Homes, and read into record emails sent to Dave Kalin, Jr.
